Results

The term "occult" comes from the Latin word "occultus", translated from the French "occulte" into English, "occult", meaning is made mysterious, secret, concealed, and understood as something that cannot be accessed, apprehended by thinking, mind, beyond understanding. This includes knowledge and practice of supernatural matters such as divination, magic, alchemy, astrology, witchcraft etc.

It's important to note that the term "occult" does not always have a bad or ominous meaning. While some historical and fictional depictions may link occult practices to evil or dark powers, many people who study the occult view it as a means of pursuing spirituality, self-improvement, and a greater comprehension of life's mysteries. As with any subject, there are broad variations in views on the nature and importance of the occult among people and cultural traditions, as well as in beliefs and behaviors related to it.

The status of the art of occult as above can be interpreted into 5 perspectives as follows:

- 1. Primitive paradigm perspectives, people believed in spirits, deities, and supernatural power that had an impact on their daily lives, they wanted to know how to appease the divine. - 2. Ancient paradigm perspectives, individuals try to discover the law of nature that will make their lives happier. The term "occult," which refers to knowledge that is hidden or esoteric and is frequently connected to mystical or supernatural components, was









mixed with philosophical concepts concerning transcendent reality, such as Neoplatonism. Occultism is the mystical search for secret knowledge (Melvin-Koushki, 2020), or gnosis, to achieve spiritual redemption. We 'll achieve the intended outcomes if we apply these insights.

- 3. Medieval paradigm perspectives, society was characterized by the intricate interaction of mystical, intellectual, and theological concepts. Religion possessed considerable power over the arts, and different esoteric activities were frequently found on the periphery of officially recognized orthodoxy. On the other hand, many try to live virtuous religious lives in order to enter heaven in the hereafter. Occult art is something else than religion (Fallon, 2023) but people perceived that it is incorrect. It leads to a bad afterlife and is a mystery and vice.
- 4. Modern paradigm perspectives, people value the knowledge obtained from the scientific process and aspire to dominate nature in order to live happy lives. The scientific method will confirm and validate hidden esoteric information as authentic knowledge (Debus, 1982 and Ferguson, 2022). Fiction and entertainment are associated with the remnants of the esoteric occult. People with low levels of education continue to be duped by occultists, which is impeding global progress.
- 5. Postmodern paradigm perspectives, People reject other paradigms' frameworks. They are interested in subjects that have historically been disregarded or prohibited from studying because they wish to completely rethink the way that people think. The fascinating knowledge found in the occult arts such as the New Age Movement, which combined astrology, alternative healing modalities, Eastern spirituality, and other occult traditions. The New Age movement placed a strong emphasis on investigating esoteric knowledge, holistic well-being, and individual spiritual development. The contemporary pagan movements incorporate aspects of ceremonial magic, nature worship, seasonal cycle celebration, and a wide range of occult practices (Strube, 2023). Popular culture has included elements of the occult into works of art, music, film, and literature. Lastly, the development of the internet has made it easier for occult knowledge to spread, giving people access to a plethora of material about alternative spirituality, magic, and divination, as well as the ability to study esoteric teachings and connect with like-minded societies.

Conclusion and Discussion

The theory and process of interpretation known as hermeneutics can be used to justify the use of the art of occult. By applying Gadamer's hermeneutics to the occult, people can gain insight into the hidden meanings and the fusion of their personal worldview with the philosophical paradigm, as well as the relevance that the occult has
